THE WARWICKSHIRE COUNTY COUNCIL (PUBLIC FOOTPATH R13 IN THE PARISH OF WOLVEY) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2018

<u>WHEREAS</u> the Warwickshire County Council ("the Council") as traffic authority for Public Footpath R13 in the Parish of Wolvey is satisfied that traffic on the said footpath should be restricted by virtue of works proposed to be executed thereon

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:-

- 1. This order shall come into operation on 10 November 2018 and may be cited as "The Warwickshire County Council (Public Footpath R13 in the Parish of Wolvey) (Temporary Prohibition of Traffic) Order 2018".
- 2. No person shall use or permit to be used Public Footpath R13 in the Parish of Wolvey for a period of 6 months commencing on 10 November 2018, or until the said works are completed, whichever is the earlier.
- 3. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.
