**TEMPORARY CLOSURE OF B4109 HINCKLEY ROAD, B4114 LUTTERWORTH ROAD,  
B4109 TEMPLE HILL & B4109 CHURCH HILL, WOLVEY HEATH**

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4109 Hinckley Road, B4114 Lutterworth Road, B4109 Temple Hill & B4109 Church Hill, Wolvey Heath to vehicular traffic as indicated below:

From the junction of Temple Hill & The Square;  
between Lutterworth Road & Bazzard Road;  
from Hinckley Road B4109 & the off-shoot of the Hinckley Road; and  
from the island of Lutterworth Road & Gipsy Lane.

The closures are required to facilitate carriageway resurfacing works.

The Order will commence on 29 October 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 1 November 2018.

PLEASE NOTE: The works will be carried out between 09.30hrs and 15.30hrs.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

PLEASE NOTE:

Access to and egress from Church Hill Close may be affected whilst works are in progress. Access to and egress from Smockington Lane will be maintained.

An alternative route will be signed and is available via: B4114 Lutterworth Road, B4112 Bulkington Lane, B4112 Nuneaton Road, B4112 Rugby Road, B4109 Wolvey Road, B4109 Bulkington Road, B4065 Coventry Road, B4065 Leicester Road, Church Road, B4029 Brinklow Road, B4029 Ansty Lane, B4029 Ansty Road, B4029 Shilton Road B4428 Coventry Road, Broad Street, The Crescent, Lutterworth Road, B4455 Fosse Way, A5 Watling Street A5, B4109 Hinckley Road and vice versa.

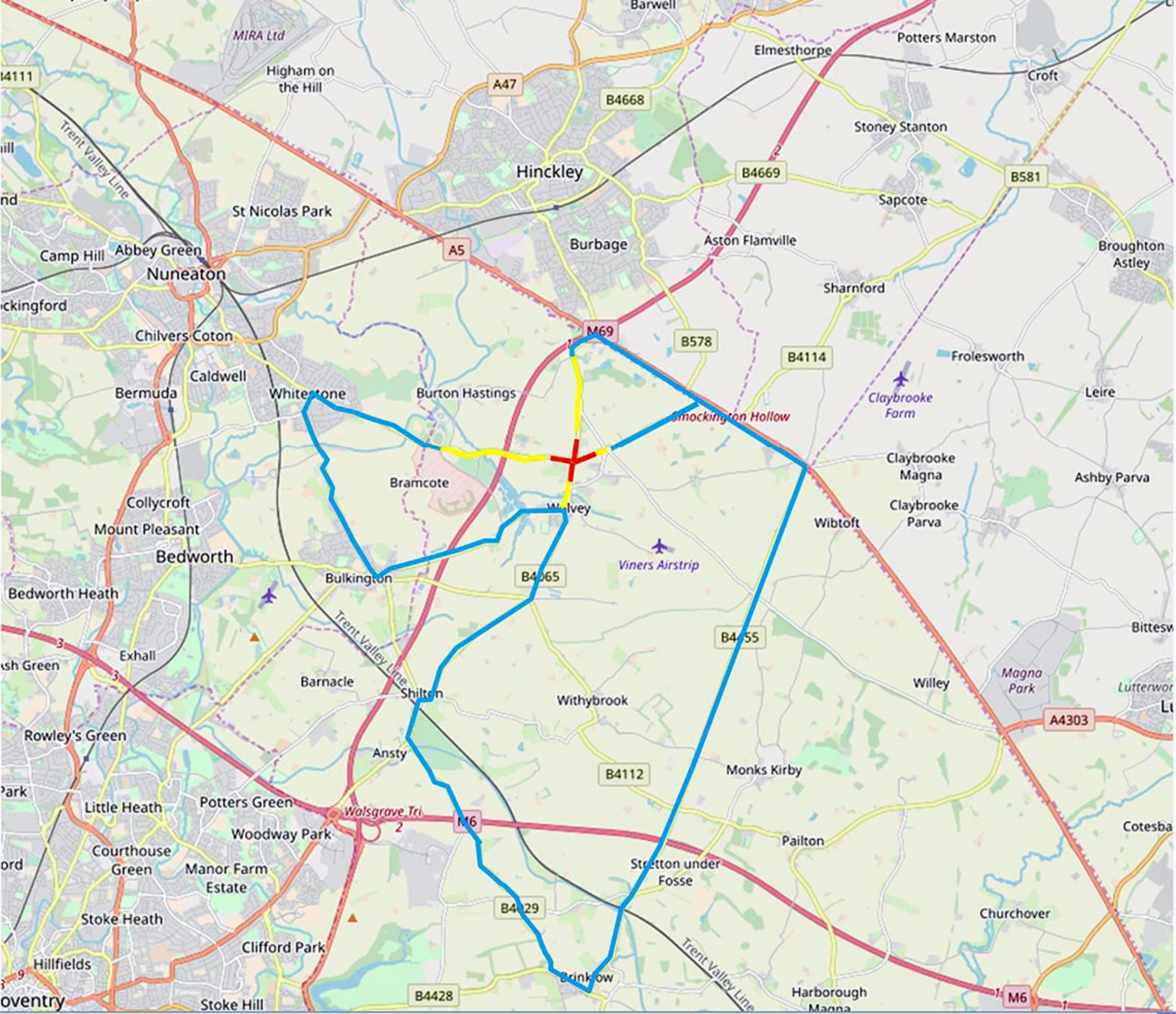
