**11.164 Declaration of Interest on Items on the Agenda**

Cllrs Hawkins & Elliott declared a prejudicial interest in the planning application for land south of the Telephone exchange, Coventry Road.

**11.165 Minutes of the meeting held on 15<sup>th</sup> August, 2011.**

RESOLVED: The minutes were confirmed and signed by the chair as a true record

**11.166 Comment and information from members of the public and members with a prejudicial interest**

A resident explained a proposal for a Community arts project which might be funded by the LEADER project. To be considered at the next meeting.

**11.168 Clerk's Report**

The following report was received and noted:

1. We have received an unqualified opinion from the External auditors
2. In the Rugby in Bloom competition we were awarded an Silver Gilt for the Square ( Community Section) and a Gold for the Wetland ( Environment section)
3. Letter received from WCC about the wall on Church Hill – comments on the safety of the wall have been sent to Rugby BC Building Control
4. WCC will install a temporary fixed flashing sign for up to 6 months on Coventry Road ( while we are waiting for funding for permanent signs to be considered)

**11.170 Planning**

11.170.1 The following update on previous Planning Applications was received

R11/0141 Land South of the Telephone Exchange, Coventry Road, Wolvey – pending (Decision deferred by planning committee until September 29th)  
This was discussed by the Council. The summary provided to the planning committee did not include the Parish Councils concern about access and egress from the site.

RESOLVED: Clerk to ask this to be provided to the planning committee when this application is next considered.

### **11.171 The proposed changes to the National Planning Policy Framework were considered by the council.**

Wolvey residents place a high value on the green belt and therefore the Council objects to the proposed changes.

Following discussion IT WAS RESOLVED that a letter be sent to MP Mark Pawsey asking how he will vote on this issue.

### **11.173 The lack of consultation and the decision by WCC to withdraw bus service 75 was considered by the Council.**

Cllrs Orchard & Knight had met with officers of Transport at WCC to discuss this problem. As a result additional Flexibus services will be provided to Nuneaton and Bedworth which will travel through Bulkington. It is hoped this will help to reduce

difficulties for Wolvey residents.

RESOLVED: Clerk to include an insert into the newsletter providing information about these new bus services.

**11.174 The Council considered supporting Wolvey Playing Fields Trust grant applications for new equipment.**

Following discussion, IT WAS RESOLVED to support the Playing Fields Trust application for funding for new play equipment and an outdoor gym. The preferred equipment for play equipment is Option2 from Komplan. Further research and consultation to take place for outdoor gym equipment IT WAS RESOLVED to make an application to Fields in Trust for the playing fields (as long as this supports the constitution of the Wolvey Playing Fields Trust ) and for the Old Cricket Field Wetland.

**11.175 Plans for the Queens Diamond Jubilee were considered**

A meeting has taken place with representatives of local groups. It was decided that the event will take place on Monday 4<sup>th</sup> June with a procession to the playing fields and a party in the park. An organising committee has been formed.

**11.176 Plans for Christmas tree 2011 were considered:**

Cllr Orchard to continue to investigate new LED lighting.  
Clerk to chase Christmas tree order as no response from Digby Farm yet.

**11.177 Vehicular Activated Signs**

The Parish Council made a request to Cty Cllr Morris-Jones that a bid be made to the Transport Capital Seminar for two vehicular activated signs for Wolvey. Cty Cllr Morris-Jones agreed to do this. The Parish Council will be asked to choose the site for these signs.

**11.178 Highways and Streetlight related matters**

1. Weeds in roadside gullies need to be cleared. Clerk to obtain quotes for this work
2. Work needs to be done clearing under trees. To be discussed with the Environment group
3. The new streetlight column has been installed on Bulkington Road and faults have been repaired on lights in Leicester Road, Coventry Road, Temple Hill and Church Hill. The bill for these repairs has not yet been received.

**11.179 Environment**

179.1 An update from the EWP was provided by Cllr Slee. Warwickshire Wildlife Trust are coming to do a survey for water voles this week. They have agreed to provide a mower and staff to cut grass in the wetland sometime in October for a small donation. IT WAS AGREED to accept this offer as long as the work can be done in October. If not, a mower will need to be hired.

Fritillary bulbs have been ordered.

It was agreed to discuss the possible registration of the Wetland with Fields in Trust with the Environment Group.

179.2 The possible purchase of a shed to store the water bowser at the village hall was discussed. The Baptist Chapel has also agreed to store it in a shed. To be discussed again at the next meeting

**11.80 The council's approach to possible future wind farm applications was considered.**
