**TEMPORARY CLOSURE OF B4109 HINCKLEY ROAD, WOLVEY**

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4109 Hinckley Road, Wolvey, from the junction with A5/M69 Island to the junction with B4114 Lutterworth Road, to vehicular traffic.

The closure is required for carriageway patching and associated works.

The Order will commence on 18 January 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 19 January 2019.

**PLEASE NOTE:** The works will be carried out between 9.30hrs and 15.30hrs.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4114 Lutterworth Road, B4114 Smockington Lane, A5 Watling Street, A5/M69 Island and vice versa.

WHEREAS the Warwickshire County Council ("the Council") as traffic authority for B4109 Hinckley Road, Wolvey is satisfied that traffic on the said road should be restricted by virtue of works proposed to be executed thereon

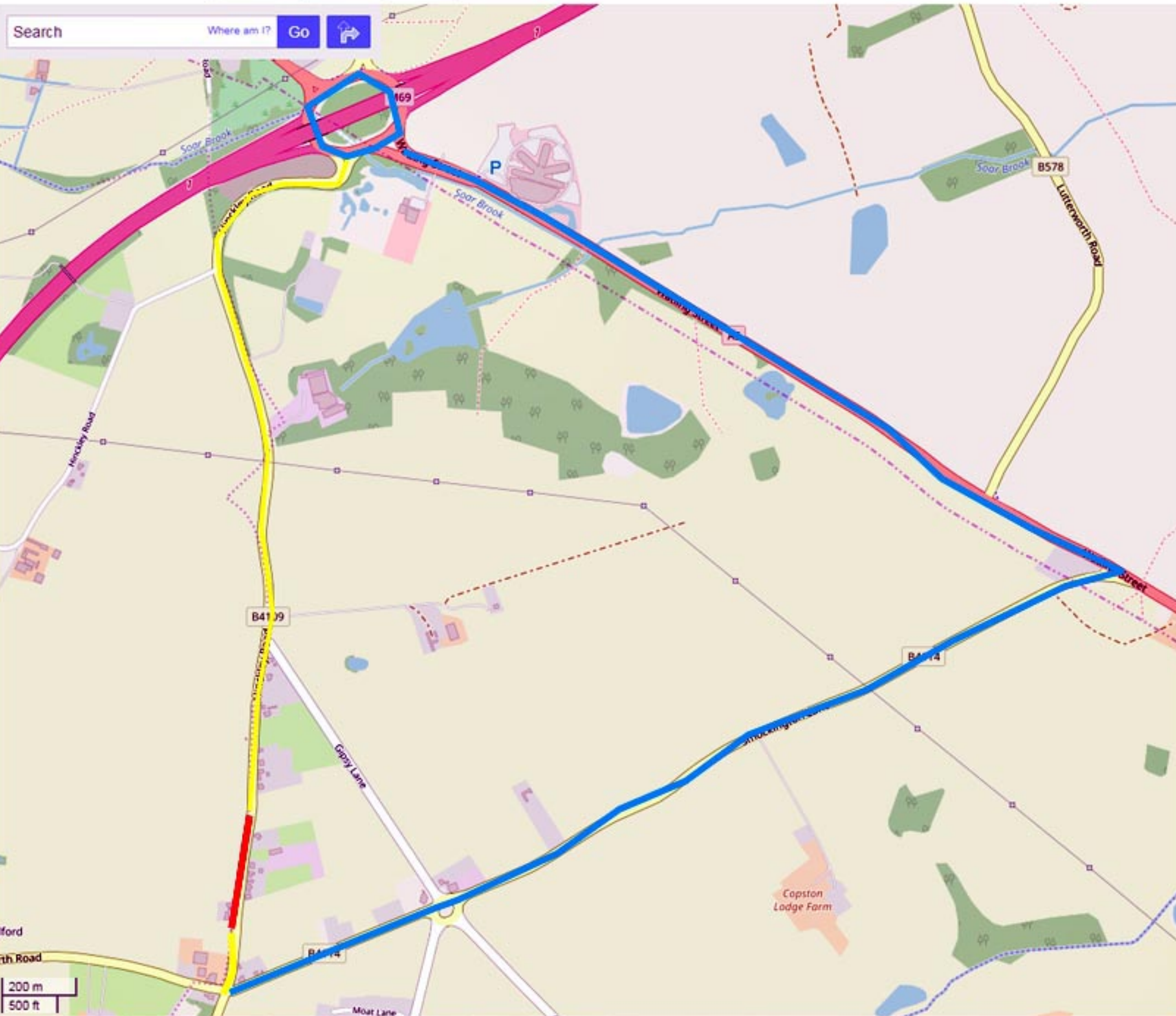
NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:-

1. This order shall come into operation on 18 January 2019 and may be cited as "The Warwickshire County Council (B4109 Hinckley Road, Wolvey) (Temporary Prohibition of Traffic) Order 2019".
2. No person shall cause or permit any vehicle other than an exempted vehicle to use B4109 Hinckley Road, Wolvey for a period of 18 months commencing on 18 January 2019, or until the said works are completed, whichever is the earlier.
3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
4. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.
